Public Comment: Karen Anderson asked about an increase of a legal service agreement on the warrant list for Children & Youth for William Bunt. Kristie Gantt, Director explained the increase was due to a large increase in case loads and court and legal involvement and is in line with the costs of other counties our class size.

Liz Bosak, Penn State Field and Forage Crop Educator gave an update on Penn State Extension. 30 workshops have been offered by the Penn State Extension Office from Pesticide Programs to Spotted Lantern Fly updates with the Master Gardener's. Becky Kaucher gave an update regarding 4'H program and FFA updates with animals attending the fair. All FFA schools were represented and gave a short update on their accomplishments with students. A reminder that the Farm & Fork Dinner sponsored by all three school districts will be held on Spetember 22nd at the Fairgrounds.

Sally Tengeres gave an update on Soil Conservation regarding farmland preservation, the county's currently no till grain drill program and Nutrient Management. They are once again part of the Chesapeake Bay Agreement and will be selecting random farms for inspection and compliance. Kristie Smith, Recycling Coordinator, spoke regarding the recycled art challenge once again featured at the fair and recycling for cans and bottles will be done during the fair.
