Commissioner Naylor made a motion o approve the Next Generation 911 Consulting Services Agreement with Mission Critical Partners which provides interconnectivity with Juniata and other outlying counties in the amount of \$27,490.00. 2018 Capital Grant Funding will be used for this. Commissioner Rudy seconded the motion. All Agreed. Motion carried.

Employee Status: Commissioner Rudy made a motion to approve the hiring of Jessica Miller, C&Y caseworker II, at an hourly rate of \$22.48 effective December 26, 2018. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Commissioner Rudy made a motion to accept the letter of resignation for Joshua Knoll, p/t dispatcher trainee, 911 effective December 10, 2018. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Commissioner Rudy made a motion to amend the agenda to approve the hiring of Eliza Grim, deputy sheriff. Commissioner Benner seconded the motion. Motion carried.
