**Approval of Minutes:** Commissioner Rudy made a motion to approve the minutes of December 12, 2016. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Naylor made a motion to approve the warrant list for the week of December 19, 2016 in the amount of \$223,978.41. Commissioner Rudy seconded the motion. Motion carried.
