Lynn Van Leaven, Veterans Affairs Director, was welcomed back after a medical leave and was acknowledged by Commissioner Naylor for receiving a Five Start Service Award for outstanding recoveries of veterans' benefits. This is the third year in a row that Perry County has received over one Million dollars in recovery of veteran benefits for residents in the County.

Sitting on the H.A.T.S. (Harrisburg Area Transportation Study) Commissioner Naylor updated the Board that the Newport Park & Ride route #34 project, \$236,000 was removed from the project due to a low bid amount in the construction phase. The Park & Ride is proposed to expand nearly double in size. The project was let on January 15 and is to proceed on the 2nd of March. Also the Harrisburg Area Transportation Study Coordinating Committee met on the 13th of February and carried the Meck's corner intersection located in Carroll and Wheatfield Townships on the Regional Transportation Project Listing ranking at number 12. The project will be considered for listing on the Transportation Improvement Program.

Kristie Smith, Times Reporter was also acknowledged for the excellent article that was done on the heroin epidemic in the County.
