Commissioner Benner opened the meeting at 10:00 AM on July 11, 2016 with the Pledge to the Flag and a moment of silence. Commissioner Benner noted the meeting was being recorded.

**Public Comment:** Dan Greene, Seda-Cog, gave an update on 2016 CDBG (community development block grant) money. \$238,600.00 has been allocated for 2016. A workshop and hearing was held in June in the Commissoners conference Room. Three municipalities have requested funding:

Oliver Township requested \$128,000 for Sewerage System Rehabilitation

Newport Borough Municipal Authority requested \$200,000 for Stormwater and Sewer separation

Bloomfield Borough Water Authority requested \$155,990 for Water main replacement on McClure Street

Steve Coop, Marysville Boro Council, expressed concerns regarding ambulance service and manpower issues throughout the County. Commissioner Benner noted this concern is being addressed through the County Healthcare Coalition.
