Commissioner Benner opened the meeting at 10:00 a.m. on May 6, 2019 with the Pledge to the Flag and a moment of silence.

Public Comments: Karen Anderson stated that her comment in the draft minutes from April 29, 2019 was not accurate.

Dave Magee commented that the Commissioners' Meeting minutes seemed to be abridged and wanted to know the reason.

Karen Anderson raised a concern that the meeting minutes do not include all comments and concerns voiced, regarding issues discussed at the Commissioners' Meeting. She also stated that there is an issue with openness and transparency. Ms. Anderson asked for an update on the RKL investigation and what the next steps in the process would be.

Approval of Minutes: Commissioner Rudy made a motion to approve the minutes of April 29, 2019 with the correction to Karen Anderson's public comment. Commissioner Benner seconded the motion. Commissioner Naylor opposed. Motion carried.

Warrant List: Commissioner Rudy made a motion to approve the warrant list for the week of May 6th for the total amount of \$414,545.63. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Meeting Business: Commissioner Naylor made a motion to approve the Cumberland-Perry Drug & Alcohol Commission 2018/2019 contract addendum. Commissioner Rudy seconded the motion. All agreed. Motion carried.

Public Comments: Dave Magee questioned what is being done to combat the drug issues within the County.

Rich Fultz stated that many overdose 911 calls come into his department as medical emergencies, so it is hard to track the actual number of overdose cases in the County. He did state that if the call is identified as an overdose situation, it is reported.

Robert Ressler stated that it will be a record-breaking year in regards to drug overdoses. He also mentioned that he has noted an increase in crystal meth usage and reported the first death associated with this drug.

Frank Campbell alerted attendees that the Rase Project is hosting a training on May 30, 2019 at the Extension Office regarding drug addiction.

Gary Eby asked for clarification on the training.
