COMMISSIONERS GENERAL SESSION August 10, 2020

Commissioner Allen opened the meeting at 10:00 a.m. on August 10, 2020 with the Pledge to the Flag and a moment of silence. The meeting was conducted via telephone conference and in person at the Extension Office Meeting Room. The meeting was recorded by the County and John McTernan.

Public Comments: John McTernan provided documentation to the Commissioners. He stated that former District Attorney Chenot made an opinion that the rights of the elderly were violated by the County in a previous meeting. He commented on a report containing information on the previous meeting that transpired between a Perry County Area Agency on Aging employee and a specific violation. Mr. McTernan stated that he had written permission from the individual to be in attendance during the investigation, but the Aging employee would not talk to him about the situation. He stated that he had met with the Aging Director and Solicitor Bunt previously about the situation. Mr. McTernan requested that the Commissioners remove Solicitor Bunt from his position.

John Holman stated that he has submitted Right to Know requests annually and the responses all say that Perry County is in compliance regarding elder abuse. He said that public hearings should be held on Aging policies. He demanded that the Chairman hold a public hearing regarding this issue. Mr. Holman also provided documentation to the Commissioners and also requested that Solicitor Bunt be terminated.

Melanie Wertz asked for additional information on COVID relief funding information that was provided by the Chamber of Commerce at a previous meeting. She specifically asked how much funding was received, was the funding in the form of grants or loans, how was it determined who received the funds, and how could she get a list of who received funds.

Rich Pluta, representing the Chamber of Commerce, stated that he had provided information regarding the PPP loan program (Paycheck Protection Program) at a previous meeting and the information he had provided came from The Center for Rural Pennsylvania. He stated out of 500 County business, 425 businesses/non-profits had received a loan from the federal government through the PPP program. Mr. Pluta also stated that it was federal funding administered by the State.

Melanie Wertz questioned if businesses that did not belong to the Chamber were informed about the program.

Rich Pluta stated that the local banks, the County, the Chamber, and the EDA all provided information to local businesses.

Meeting Business: Heather Kelly-Weisen, from SEDA-COG, presented information regarding the proposed project selections for the FFY 2020 CDBG grant funding. She stated that the total amount of project funding available is \$ 222,352. Commissioner Eby made a motion to accept the presented projects for CDBG funding, based on the review of the information provided and the community impacts (listed below). Commissioner Watson seconded the motion. All agreed. Motion carried.

- Newport Borough Water Authority Well #1 Technology Upgrade & Rehabilitation \$81,176
- Loysville Village Municipal Authority Inflow & Infiltration Project \$81,176
- Newport Borough Sidewalk and Curbs Improvements Project \$60,000

Commissioner Watson made a motion to approve the CDBG Budge Revision Certification to allocate remaining funds in the amount of \$4,374.97 to the Loysville Village Municipal Authority 2018 Inflow and Infiltration project. Commissioner Eby seconded the motion. All agreed. Motion carried.

Ryan Simon, from Cumberland-Perry Drug & Alcohol Commission provided information on the grant agreement with the PA Department of Drug & Alcohol Commission. Commissioner Eby made a motion to approve the 5-year grant agreement with the PA Department of Drug & Alcohol programs, based on information provided by Cumberland-Perry Drug & Alcohol Commission and after review by Solicitor Bunt. Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Watson made a motion the approve the Cumberland-Perry Drug & Alcohol Commissioner 2020/2021 contracts (listed below). Commissioner Eby seconded the motion. All agreed. Motion carried.

He also commented that he wanted a meeting with Commissioner Watson and Solicitor Bunt to explain discrepancies. Mr. McTernan said that he would be participating in a radio program this coming Thursday to bring out these issues. He stated that the County would be torn apart during the radio show and requested representation from the County on the program.

John Holman stated that Commissioner Allen was present during a previous meeting and again requested a public meeting which would allow for more time to discuss the elder violations. He commented that he would like Commissioner Allen to chair the public meeting and provided all the necessary information.
