COMMISSIONERS GENERAL SESSION September 28, 2020

Commissioner Allen opened the meeting at 10:00 a.m. on September 28, 2020 with the Pledge to the Flag and a moment of silence. The meeting was conducted via telephone conference and in person at the Extension Office Meeting Room. The meeting was recorded by the County and John Holman.

Public Comments: Alane Balchunas thanked Jim T. Ryan, Staff Writer of the Perry County Times, for his September 24th article regarding third party mail-in ballot applications being sent to Perry County residents.

Dave Magee thanked the Commissioner that is a member of the HATS Committee, as the participation has resulted in a grant for a much-needed bridge project in Marysville.

John Holman stated he was following up on the complaint that he and John McTernan submitted to the Area Agency on Aging as they had not heard back in five days. He asked if the Commissioners would follow up to see why a response has not been issued.

John McTernan said that on August 31st he had submitted a complaint to the Area Agency on Aging and had not heard anything back. He asked Commissioner Eby if he had spoken to Mr. Wirth about their complaint. He stated that the complaint from five years ago is ongoing and it is currently valid. Mr. McTernan asked of the Area Agency on Aging is going to investigate the complaint.

John Holman stated that the County Commissioners had called to set up a meeting with him, Commissioner Eby, Solicitor Bunt, and Director Wirth to discuss the County's compliance regarding elder abuse investigations. He commented that he came to the meeting, but they would not consent to having Mr. McTernan on the phone or being recorded. Mr. Holman stated that Commissioner Eby said they could schedule another meeting and he asked if a decision had been made to have another meeting. He also asked if there would be a public hearing. He stated again that he had not heard back regarding the complaint.

Karen Anderson asked for an update on the Duncannon District Justice and also questioned if the County is still paying two people to do the job.

Randy Waggoner stated that the Centre Township Tax Collector has been hospitalized, but said that her assistant has stepped up to fill the role in the township. He commented that the assistant will be appointed

in the short term to collect taxes and he said he will provide information that can be posted on the County website.

Approval of Minutes: Commissioner Eby made a motion to approve the minutes of the September 21, 2020 meeting. Commissioner Watson seconded the motion. All agreed. Motion carried.

Approval of Warrant List(s): Commissioner Watson made a motion to approve the Warrant List dated September 29, 2020 in the amount of \$841,600.28. Commissioner Eby seconded the motion and noted that the list contains CARES Act funding allocations that is being reimbursed back to the General Fund. All agreed. Motion carried.

Commissioner Watson made a motion to approve the Warrant List dated September 23, 2020 in the amount of \$317.07. Commissioner Eby seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the Warrant List dated September 21, 2020 in the amount of \$15,200.59, and noted that the amount would be reimbursed back to the General Fund as a CARES Act expense. Commissioner Watson seconded the motion. All agreed. Motion carried.

Meeting Business: Commissioner Watson made a motion to approve the listing of CARES Act Block Grant allocations in the total amount of \$355,442 (list attached). Commissioner Eby seconded the motion. Commissioner Eby abstained, stated that he would not be voting due to his involvement with two organizations on the listing. Motion carried.

Employee Status: Commissioner Watson made a motion to approve the termination of Thomas Cervin, Full Time Correctional Officer, at the Perry County Prison effective September 23, 2020. Commissioner Eby seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to accept the resignation of Ashley Mitchell, Deputy Prothonotary, in the Prothonotary/Clerk of Courts Department effective October 9, 2020. Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Watson made a motion to rescind the action previously taken accepting Anna Shenk's letter of resignation. Commissioner Eby seconded the motion. All agreed. Motion carried.

Solicitor's Report: None

Public Comments: John McTernan provided information to Commissioner Eby on his radio show and invited him on the show on Friday. He stated that he was on the phone during the meeting Mr. Holman had with him, Solicitor Bunt, and Mr. Wirth. He commented that Solicitor Bunt called John Holman a liar, and asked that Commissioner Eby keep the meetings in order and requested that Solicitor Bunt apologize to Mr. Holman.

John Holman stated that the Area Agency on Aging refused to accept his complaint, and asked Commissioner Eby and Solicitor Bunt if this was a violation of state/federal law. He stated that no one knows the laws regarding the elder abuse investigations and asked if this was a true statement. Mr. Holman stated he had documentation regarding laws and the set of procedures for conducting investigation from another state agency. Mr. Holman stated that everyone must follow the same federal law.

Dave Magee made a request that the Commissioners consider the employment of a part time librarian at the Perry Historians. He said this would enhance access to the records.
