Commissioner Naylor made a motion to approve the contract for Legal Services for Robin Holman Loy, Esquire for Domestic Relations at a cost of \$150.00 per hour effective October 1, 2015 through September 30, 2020. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Rudy made a motion to table the approval of nominations for Farm Director and Public Director for the Perry Conservation District Directors until the nominating committee names are received. Commissioner Benner seconded the motion. Motion carried.

Employee Status:

Commissioner Rudy made a motion to approve the hiring of Nicholas Shawver for the position of maintenance worker at an hourly rate of \$13.20 effective January 4, 2014. Commissioner Benner seconded the motion. Motion carried. Commissioner Naylor opposed.
