CDBG Fiscal Year 2012- Penn Township, Sunshine Hills project in the amount of \$143,000.00

Approve 2013 Competitive grant with Penn Township in the amount of \$500,000.00 for water system upgrades for the township. This grant allows the community to undertake an \$800,000 dollar project.

This agreement allows Perry County to enhance its responsibilities for victim notification as well as provide additional notification service to county residents regarding the location of an offender. This contract is in effect from January 1, 2015.
