## COMMISSIONERS GENERAL SESSION May 18, 2020

Commissioner Allen opened the meeting at 10:00 a.m. on May 18, 2020 with the Pledge to the Flag and a moment of silence. The meeting was conducted via telephone conference and the meeting was recorded by the County.

**Public Comments:** Mary McCarty, from the U.S. Census Bureau, provided an update on the 2020 Census. She stated that the national response rate is 69.5% and Perry County's response rate was 62.6%. Ms. McCarty also commented that response rates are low in the western end of the county.

**Approval of Minutes:** Commissioner Eby made a motion to approve the minutes of the May 11, 2020 meeting. Commissioner Watson seconded the motion. All agreed. Motion carried.

**Meeting Business:** Commissioner Eby made a motion to open the county buildings effective Friday, May 22 at 8:00 a.m. by appointment only and with additional guidelines forthcoming. Commissioner Watson seconded the motion with the guidelines being sent out later in the week. All agreed. Motion carried.

Commissioner Eby made a motion to recall furloughed employees based on consultation with department heads on a case by case basis and encouraged employees, if permitted, to work from home during the yellow phase. Commissioner Watson seconded the motion based on a case by case basis. All agreed. Motion carried.

**Employee Status:** Commissioner Watson made a motion to approve the appointment of April Skethway to the position of Part-Time Administrative Assistant in the Perry County Conservation District effective May 27, 2020 at an hourly rate of \$14.03. Commissioner Eby seconded the motion. All agreed. Motion carried.

Solicitors Report: None

**Public Comments:** Karen Anderson stated that she was having trouble hearing Commissioner Watson. She asked if the Commissioners had additional information pertaining to the 5 new cases of COVID-19 posted on the Department of Health's website. Ms. Anderson also questioned if nursing homes are reporting their numbers due to this being an issue in other parts of the state.
