Letter of Agreement for providing services in accordance with the Family Center Program for the term of July 1, 2013 to June 30, 2014. The Family Center has been receiving a grant from D.P.W. in the amount of \$155,427. since 1992 for funding that requires a \$10,000 county match which is received from the Human Service Development Fund and Children & Youth Services. Commissioner Naylor made a motion to sign the Letter of Approval. Commissioner Rudy seconded the motion. Motion carried.

Employee Status: Commissioner Naylor made a motion to go into executive session to discuss the hiring of an employee for the Assessment Office. Commissioner Rudy seconded the motion. Motion carried. The meeting reconvened and Commissioner Naylor made a motion to approve the hiring of Dennis Kent, for a Office FIeld Assessor for the Assessment Office, effective June 3, 2013, grade 6, starting salary \$10.87 hourly. Commissioner Benner seconded the motion. Motion carried. Commissioner Rudy opposed the motion unless a 3 year contract would be done with the employee to make sure he does not leave county employment after completion of training because of the cost of training.

Based on the recommendation of Stacey Nybeck, PCTA Director, Commissioner Rudy made a motion to hire Russell Little and Jim Sheaffer as part time drivers, effective May 21, 2013, grade 4, \$9.34 hourly. Commissioner Naylor seconded the motion. Motion carried.
