Karen Anderson asked questions regarding the change in the balance of the County budget.

Malinda Anderson gave an update for Bloomfield Borough. The Opt-In for the gambling plan proposed by Governor Wolfe will be in compliance for the December 31st deadline.

Frank Campbell noted that the county has many people using the Clean & Green to get a discount in taxes. 63.8% of the acreage is in Clean & Green. Adding Tuscarora Forest, State Parks and Game Lands it comes to a total of 81.5%. The other 18.5% of the acreage in the county pays the full amount of taxes but the number is less since it does not include municipalities, non-profits, etc.

Commissioner Rudy made a motion to appoint Kathy Burkholder as a Section 504 Compliance officer for the County. Commissioner Naylor seconded the motion. Motion carried.
