Commissioner Benner opened the meeting at 10:00 AM on November 21, 2011 with the Pledge to the Flag and a moment of silence.

Public Comments: Terry Flickinger expressed his concerns with the treasurer elect, Mary Reisinger. Solicitor Bunt gave a legal research opinion of his finding.

Commissioner Amsler made a motion to approve the minutes of November 7, 2011. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Naylor made a motion to sign the warrant lists in the amount of \$91,577.60 for the week of November 14, 2011 and \$370,191.47 for the week of November 21, 2011. Commissioner Amsler seconded the motion. Motion carried.

A public hearing notice was advertised for 9:30 a.m. on Monday, November 21, 2011 for the purpose of receiving public comment on a proposed application to DCED for up to \$55,000 in HOME Investment Partnership Funds to obtain housing for homeless disabled individuals or a family with a disabled head of household. Commissioner Amsler made a motion to Adopt Resolution 2011-17 authorizing the filing of an application for HOME program funds with DCED. Commissioner Naylor seconded the motion. Motion carried.

Based on the recommendation of the Mh/IDD Board, Commissioner Amsler made a motion to approve the following contracts:

The major change DPW is initiating for the five-county collaborative is to reduce the cap on reinvestment savings from 4 percent to 3 percent. Commissioner Amsler seconded the motion. Based on the recommendation of Pennoni Associates, Inc., Commissioner Naylor made a motion to approve the relocation for a weight limit sign for Enslow Bridge (Bridge No. 7) for the sum of \$350.00 Redrock Construction Inc. Commissioner Amsler seconded the motion. Motion carried.

Telephone bids were received to pressure wash the exterior of the prison and remove and replace damaged caulking, seal cracks between stone blocks and re-seal windows, doors and walls.
