Public Comments: Andrew Bender provided an update on the Dellville Bridge fire investigation. He stated that Pennsylvania State Police filed charges against two juveniles for the fire prior to the statute of limitations running out.

Frank Campbell provided information on an upcoming Naloxone Workshop being held on December 12, 2019 at the Madison Grange in Loysville. He also thanked Jack Carroll from the Cumberland Perry Drug and Alcohol Commission for sponsoring the workshops.

Karen Anderson also expressed appreciation to the Cumberland Perry Drug and Alcohol Commission for the Naloxone Workshops and stressed the importance of the training.

Miriam Briscoe encouraged participation in the Naloxone Workshops as well.

Harva Owings-Baughman asked if the items being reviewed at the 1:00 p.m. public budget meeting would be available for review prior to the meeting.

Approval of Minutes: Commissioner Naylor made a motion to approve the minutes of October 28, 2019. Commissioner Benner seconded the motion. Commissioner Rudy abstained. Motion carried.

Warrant List: Commissioner Naylor made a motion to approve the warrant list for the week of October 28, 2019 in the amount of \$107,449.88. Commissioner Rudy seconded the motion. All agreed. Motion carried.

Employee Status: Commissioner Naylor made a motion to approve the appointment of Noah P. Cline to the position of full-time Deputy Sheriff, in the Sheriff’s Office effective November 5, 2019. Commissioner Rudy seconded the motion. All agreed. Motion carried.

Public Comments: Dave Magee stated that there could be an additional 10-15 homes built in the Marysville area in addition to the 12 already listed with the Assessment Office and will add to the County’s tax base.

Miriam Briscoe encouraged individuals to attend the Naloxone Workshop and to consider bringing along someone to the training that could benefit from the information.

Gary Eby asked if there were any success or failure rates on the Prison Vivitrol Program and also if follow up was done with participants.

Jack Carroll stated that follow up and statistics are requirements of the grant for the program and many factors are tracked.

Andrew Bender stated that Trooper Jeffrey Vitek made the charges against the two individuals happen and should be recognized for his hard work on the investigation.

Harva Owings-Baughman asked what the hourly rate on the Stevie Jo Davis contract was.
