Commissioner Benner opened the meeting at 10:00 AM on October 28, 2013 with the Pledge to the Flag and a moment of silence.

**Public Comment:** None

Commissioner Rudy made a motion to approve the minutes of October 21, 2013. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Naylor made a motion to approve the warrant list for the week of October 28, 2013, in the amount of \$121,175.59. Commissioner Rudy seconded the motion. Motion carried.

A Public Hearing was held at 10:00 a.m.to discuss public input to approve the FY 2011 Community Block Grant Budget Modification. Commissioner Rudy made a motion to reallocate funding from the Tyrone Township Sewer and Oliver Township Sewer projects to the Landisburg Borough Playground Project in the amount of \$79,020.83. Commissioner Naylor seconded the motion. Motion carried. The sewer projects came in under the budgeted allocated prices.

Based on the recommendation of the MH/IDD board, Commissioner Naylor made a motion to approve the contract with PA Lifesharing, LLC. In the amount of \$15,000 for IDD services. This is a new contract and an Intellectual and Developmental Disabilities Provider. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Rudy made a motion to approve the APEX agreement for the Perry County Transportation Authority. Commissioner Naylor seconded the motion. Motion carried. This is a renewal agreement and outlines the terms for this organization to act as a sub-contractor for PCTA to provide transportation as needed.

The Commissioners received a request from Mike Minich, Chairman of the Local Emergency Planning Committee regarding confirming Tom Bell, EMA Coordinator, Esther Rowe, Deputy Coordinator and Wesley Smith, Dispatcher to the Local Emergency Planning Committee. Commissioner Naylor approved this request. Commissioner Rudy seconded the motion. Motion carried.
