COMMISSIONERS GENERAL SESSION July 20, 2020

Public Comments: Karen Anderson asked for an update on communication with the Amish and Mennonite communities regarding the COVID-19 virus. She voiced concerns regarding buses coming from out of the County for Amish social gatherings in the western part of the County. Commissioner Eby provided an update on communication with the communities and stated that he anticipated ongoing communication with the officials in the Amish and Mennonite groups. He commented that starting today from noon until 3:30 p.m. COVID testing, hosted by Sadler Health, would be available at the Perry Health Center. Commissioner Eby stated that reservations were required and individuals could call 717-218-6670 to make an appointment as testing would be available each Monday and Wednesday. He commented that eventually the testing unit would become mobile and move throughout the western end of the County. Commissioner Eby also said that mobile testing in the eastern part of the County was also in development with Hamilton Health. He stated that the unit would provide testing services 2 days per week and was anticipated to be up and running by the end of the month

Approval of Minutes: Commissioner Watson made a motion to approve the minutes of the July 13, 2020 meeting. Commissioner Eby seconded the motion. All agreed. Motion carried.

He stated that he had received a scheduling order which had the dates of September 22 and 23 for the hearings. Solicitor Bunt said that these dates were very close to election time and any changes resulting from those hearings will be very difficult for County election offices to implement. He also stated that all counties in the Commonwealth had received notice of a second lawsuit, filed in Commonwealth Court, by the Pennsylvania Democratic Party and Others regarding the election process and specifically the mail-in ballot procedures. He stated that all 67 counties will need to be very flexible regarding any changes that result from these lawsuits, as election time is the beginning of November. Solicitor Bunt commented that no action is required at this time.
