

2021 MUNICIPAL ELECTION UMOVA NOTICE

The following instructions are instructions regarding voting by absentee ballot:

1. You may request an absentee ballot from this office at any time prior to a primary or election. However, if time does not permit you to receive and return an official absentee ballot, you are entitled to vote using the Federal Write-in Absentee Ballot (FWAB).

2. You may use the FWAB to vote for a candidate for President of the United States, and U.S. Representative (Representative in Congress) as well as candidates for all state and local offices

3. To vote, refer to page 3 of the FWAB.

To vote for President of the United States and U.S. Representative (Representative in Congress) – write in the name of the candidate in space provided on the FWAB.

To vote for state and local offices or for ballot initiatives – write the names of candidates or the ballot initiative in the Addendum Section of the FWAB

Under the **Office/Ballot Initiative** heading, enter the office the candidate is running for or the Title of the Ballot Initiative (referendum).

Under the **Candidate Name, Party Affiliation or Initiative Vote** heading, list the name of the candidate you wish to vote for, or if you are voting on a Referendum question write “yes” or “no.”

This is an official notice of an election to be conducted on 11/02/2021 in Perry County. You may register to vote and request an official absentee ballot by using the Federal Postcard Application (FPCA), available at www.votespa.com or www.fvap.gov. You may apply for an absentee ballot by submitting your FPCA by fax to (717) 582 - 5162, or by email to bdelancey@perryco.org. Please send the original signed application to the Voter Registration Office, PO Box 37, New Bloomfield, PA 17068.

You may request an absentee ballot from this office at any time prior to a primary or election. However, if time does not permit you to receive and return an official absentee ballot, you are also entitled to vote using the Federal Write-in Absentee Ballot (FWAB). Military electors may also use the FWAB to register to vote and vote simultaneously.

You may use the FWAB to vote for **all** state and local offices, and ballot initiatives.

To vote for state and local offices or ballot initiatives, write the names of candidates or ballot initiatives in the Addendum section of the FWAB. Under the **Office/Ballot Initiative** heading, enter the office the candidate is running for or the title of the Ballot Initiative (referendum). Under the **Candidate Name, Party Affiliation or Initiative Vote** heading, list the name of the candidate you wish to vote for, or if you are voting on a Retention or Referendum question write “yes” or “no.”
