INSTRUCTIONS TO VOTER:

- 1. To vote you must blacken the oval completely. An Oval blackened to the left of the name of any candidate indicates a vote for that candidate.
- 2. To vote for a person whose name is not on the ballot, you must blacken the oval to the left of the
 - line provided, and write or print the name in the blank space provided for that purpose. If you make a mistake, do not erase. Ask for a new ballot.
- 3. After marking the ballot of your choice of candidates, proceed to the scanner and insert your ballot. The scanner screen will show that the ballot has been cast.

The following parties are eligible to nominate their candidates at this General Primary Election: Democratic and Republican. Libertarian Party and Green Party and are not eligible to nominate their candidate for election to public office at the May 17, 2022 Primary. Nominations of the Green Party and Libertarian party candidates for any public office must be made by filing nomination papers. The Green Party and Libertarian Party is considered a minor political party; however, the Green Party and Libertarian Party are still required to file nomination papers and will not appear on the Primary Ballot. Information for the municipalities in each of the Congressional, Senatorial and Legislative Districts is listed below on the list of polling places and can be obtained at the Perry County Voter Registration Office, Veterans Memorial Building, New Bloomfield, PA 17068.
