**It is critical to know that if there is any deviation in the information between your IRS info and your DUNS and SAM -- especially your legal address.**

- If this information is not correct and identical on all accounts, we may not be able to submit your application.
- This includes abbreviations or capitalization of your legal address, and legal company / organization name.
- It is imperative that these three matches, starting with the IRS, then the DUNS and then the SAM account.

The simplest way to check this is to pull up your charitable listing using your EIN and compare it to DUNS and then SAM info.
