COMMISSIONERS GENERAL SESSION January 23, 2023

Commissioner Allen opened the meeting at 7:00 p.m. on January 16, 2023 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person at the Buffalo Township Building located at 22 Cherry Road, Liverpool. The meeting was recorded by the County.

Announcements/Updates: Commissioner Allen said he appreciated the good turnout at the meeting.

Public Comments: Art Lindsay questioned how the County get involved with distributing federal grant funds and how they determine who get the funding. He said the township had started working with the grant writing team in 2021 and if they had been able to submit the grant at that point they would not have had to payback 30% of the funding. Mr. Lindsay said everyone drug their feet and now they had received a letter stating that the grant writers would not be assisting them with the project. He said the project would address a major roadway between routes 11/15 and 22/322 and said he does not think its fair how grant assistance is determined. Mr. Lindsay further said he felt that New Bloomfield does not pay attention to the other side of the Juniata River. He commented that the Commissioners should take a look at Meadow Grove Road to see how needed the project is. He stated that he would be happy to get grant funding in phases to address the roadway project. Mr. Lindsay also said that the township engineer and another individual had walked the site and said it was a good fit for a multimodal grant.

Tony Liddick asked for an update on broadband funds and if any additional towers were going to be built.

Tim Albright questioned if the Commissioners were considering offering the ability to conduct business with the County virtually. He mentioned that County offices do not offer e-payment and said upgrading the way the County conducts business with residents would be good.

Stan Good said he was glad to hear that the County was redoing the broadband RFP, since ZITO was a bidder on the first RFP and in his opionion their service is bad. He asked who makes the guidelines that the broadband RFP must follow.

Gary Witmer Sr. said that he has 25 acres and had sold off 5 or 6 building lots off the original farm. He further commented that he is living on a fixed income and his tax bill increased right after COVID. Mr. Witmer said the interior of his home had not changed and he didn't understand how taxes could be increased like they were. He stated that someone should go out and look at the properties before deciding to increase the taxes. He said that he is paying more for taxes now than he did 10 years ago. Mr. Witner said the County split his property and he now gets two tax bills, but the property is all under one deed.

Tony Liddick, said he writes the permits in the township and he said he has seen houses being bought for over \$400,000 but the taxes only show an assessed value of \$200,000. He also commented that there are other

properties that are not being taxed correctly such as properties with homes on them but the taxes don't show a home. Mr. Liddick said he uses Google Earth and he questioned why the County assessment office doesn't use it

Art Lindsay said that topo-maps are used to assess properties and he questioned how that can be accurate.

Tim Albright said the Food Bank used to bring food to the Good Shepherd Lutheran Church as a satellite location. He said they no longer bring food to the church and asked why that happended.

Art Lindsay said the Food Bank said it was due to lack of funding from the County that they no longer distribute. He asked who funds the Business Inspection Underwriters as the township is having issues with them.

Tim Albright asked who's responsible for CapTax and said the late fees and summons seem to all go through the Loysville MDJ Office. He explained a situation he had with the organization and the poor service he received.

Dr. Patricia Gutheil said she was familiar with some of the topics being discussed.
