**Announcements/Updates:** Commissioner Allen read a statement from Commissioner Watson stating that she was not in attendance at the meeting due to meeting with Senator Casey about the Downtown Revitalization Project involving nine boroughs in Perry County.

**Public Comments:** Shannon Hines provided information on two upcoming UPMC health screening events. She said the events will offer free blood pressure screenings, blood glucose testing, and BMI measurements for individuals 18 years and older. Ms. Hines commented that the first event will be held on May 11 at the Marysville/Rye Senior Center and the second will happen on May 25 at the Babs Curran Senior Center. She also stated that the information would be available on the County website.

**Approval of Minutes:** Commissioner Allen made a motion approve the minutes from the March 27, 2023 meeting. Commissioner Reisinger seconded the motion. All agreed. Motion carried.

**Approval of the Warrant List(s):** Commissioner Reisinger made a motion to approve the warrant lists totalling \$552,570.87. Commissioner Allen seconded the motion. All agreed. Motion carried.
