COMMISSIONERS GENERAL SESSION June 13, 2022

Commissioner Allen opened the meeting at 10:00 a.m. on June 13, 2022 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Conference Room. The meeting was recorded by the County.

Announcements/Updates: Commissioner Eby stated that effective July 16th, the Pennsylvania Department of Human Services would be implementing the 988 National Suicide Prevention Lifeline. He said individuals can call 1-800-273-8255 until the new system is live to reach suicide prevention counselors. He said additional information about the new service was available on the County website.

Commissioner Eby reminded the public that COVID is still an issue. He said 111,000 cases had been reported statewide for the month of May. Additionally, he stated that there had been 591 deaths nationwide during the month of May, which was twice the amount of the previous month. Commissioner Eby said the numbers are modest due to the positive home tests that are never reported. He urged the public to continue to take preventative measures to help slow the spread of the virus.

Commissioner Allen announced that the June 20, 2022 meeting would take place at the New Buffalo Fire Hall at 7:00 p.m.

Public Comments: Dan Kilgore said he met with Just for Today and said they agreed to work together. He commented that he also met with the township on land utilization and requested that the County go in with him on the use of his land. He provided the Commissioners with additional handouts. Mr. Kilgore said the township is going from no zoning to zoning but they cannot tell him when. He said this is stopping him from getting a 501(c)(3), but said if the County would do a letter of intent it would help.

Taira Little thanked Gladys Carns for all her hard work organizing the Employee Wellness and Safety Day last week. She also thanked the Commissioners for allowing the Chamber of Commerce and EDA to be a part of the event.

Approval of Minutes: Commissioner Eby made a motion to approve the minutes from the June 6, 2022 Commissioners' Meeting. Commissioner Allen seconded the motion. All agreed. Motion carried.

Employee Recognition: Commissioner Allen acknowledged Correctional Officer, Daniel Altemus' 25 years of County service. Additionally, he presented a certificate of service to Neil Imes, Conservation District, for his 15 years of County service.

Meeting Business: Commissioner Eby made a motion to award the bid for #2 fuel oil to Swenson Fuels, Inc. at a price of \$5.099/gallon. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to award the bid for propane to W.C. Eshenaur & Son Inc. at a price of \$1.7130/gallon. Commissioner Allen seconded the motion. All agreed. Motion carried. Commissioner Eby stated that these contracts would take effect July 1st.

Commissioner Allen made a motion to approve the service agreement with the Blain Senior Citizens' Center. Commissioner Eby seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve Resolution 2022-10 approving the submission of a DCED Multimodal Transportation Fund Grant for the Perry County Main Street Redevelopment Project. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the MH/IDD contracts for Early Intervention, Intellectual and Developmental Disabilities, and Mental Health for fiscal year 2021/2022 in the total amount of \$960,093 (attached). He commented that the contracts are to ensure there are enough services due to the short supply and also due to the large increase in need for the services. Commissioner Eby said that the contracts are for Cumberland and Perry County and Cumberland had already approved the contracts. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Allen made a motion to approve the MH/IDD contracts for Early Intervention for fiscal year 2022/2023 in the total amount of \$1,231,822 (attached). Commissioner Eby seconded the motion, with the same comments as previously stated. All agreed. Motion carried.

Employee Status: Commissioner Allen made a motion to approve the appointment of Brian Barrick and Evan Ricker to the position of Part Time Correctional Officer at the Perry County Prison effective June 14, 2022 at an hourly rate of \$20.83. Commissioner Eby seconded the motion. All agreed. Motion carried.

Solicitor's Report: Solicitor Bunt commented on the ongoing date issue debate regarding mail-in ballots. He stated that based upon a 2021 challenge the Supreme Court of the United States declined to overrule a Circuit Court decision resulting in the decision that dates are irrelevant. He commented that he anticipates that the Pennsylvania Department of State will be sending out communication at some point indicating that dates are not required on mail-in ballots. Solicitor Bunt said this could result in only signatures be required on the mail-in ballot envelopes.

Public Comments: None

Comments from the Press: Andrea Kitner asked what the Multimodal Transportation Fund grant was being used for and also what the Main Street project was. She further questioned how much the grant was for.

Commissioner Allen remined the public that the next Commissioners' meeting would take place at the New Buffalo Fire Hall at 7:00 p.m.

Commissioner Eby made a motion to adjourn at 10:23 a.m. Commissioner Allen seconded the motion. All agreed. Motion carried.
