Announcements/Updates: Commissioner Allen announced that there would not be a Commissioners' meeting on August 8, 2022.

Commissioner Eby reminded attendees of the Department of Transportation Reconnecting Communities Pilot (RCP) Grant Program. He said it is a nationwide program with a \$195 million dollar pool of funds. He commented that applications are currently being accepted and he encouraged municipalities to submit projects. Commissioner Eby said information on the program is available on the County website.

Public Comments: Jason Finnerty stated that the initial round of project collection for the Picture Perry Comprehensive Plan has been completed.
