#### COMMISSIONERS GENERAL SESSION September 12, 2022

Commissioner Allen opened the meeting at 10:00 a.m. on September 12, 2022 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Conference Room. The meeting was recorded by the County.

**Announcements/Updates:** Commissioner Eby announced that he and Commissioner Allen had attended a fundraising event held by the Millerstown Senior Center on Saturday. He commented that a portion of the event focused on honoring first responders, and specifically Rich Fegley was recognized for his 50+ years of emergency service work in the community.

Commissioner Eby also stated that the Harrisburg Area Transportation Study (HATS) announced that Perry County would be receiving \$2.4 million dollars in RTP funding over the next two years. He said that the funding will be used for cosmetic rehabilitation on six of the County's covered bridges, as well as a large sidewalk project in Newport Borough. Commissioner Eby also mentioned that the funds will be used to perform a study in Millerstown for future development of pedestrian and bicycle paths from downtown to the park.

Commissioner Eby commented that Perry County is on the edge of the spotted lantern fly epidemic. He urged residents to take an active role in the situation and demonstrated a spotted lantern fly trap.

Commissioner Watson said the Commissioners attended the 109<sup>th</sup> Annual Perry County Association of Township Officials Convention on Saturday. She stated that the County was well represented by departments such as the Conservation District, Emergency Management, and 911. Commissioner Watson did note the low attendance at the event, but said that the breakout sessions were very informative.

**Public Comments:** Dr. Pat Gutheil commented that she also attended the Township Convention and it was a good event.

**Proclamation Presentations:** Commissioner Allen presented proclamations, in recognition of Hunger Action Month, to Neighbor Helping Neighbor Food Bank, Bread of Life Outreach, and the Central Pennsylvania Food Bank.

**Approval of Minutes:** Commissioner Watson made a motion to approve the minutes from the August 29, 2022 Commissioners' Meeting. Commissioner Eby seconded the motion. All agreed. Motion carried.

**Approval of the Warrant List(s):** Commissioner Eby made a motion to approve the warrant lists in the total amount of \$200,517.60, and noted that \$30,048.21 was ERAP funding. Commissioner Watson seconded the motion. All agreed. Motion carried.

**Meeting Business:** Commissioner Watson made a motion to approve the FY 2022 CDBG project allocations.

- Marysville Borough Park and Access Improvements \$95,000
- Loysville Village Municipal Authority Inflow & Infiltration partial funding \$7,900

Commissioner Eby seconded the motion. All agreed. Motion carried.

Tyler Dombroski, SEDA-COG, said he had met with the Commissioners regarding the potential projects. He noted that the amount of funding for the Loysville project should be \$7,138 and he would follow up on the funding amount.

Commissioner Eby made a motion to approve the FY 2020 CDBG Subrecipient Agreement with Loysville Village Municipal Authority. Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Watson made a motion to approve the appointment of Kim Grundon to the Cumberland-Perry Drug & Alcohol Commission Advisory Board. Commissioner Eby seconded the motion based on the recommendation of the Commission and her qualifications. All agreed. Motion carried.

Commissioner Watson made a motion to approve the Cumberland-Perry Drug & Alcohol Commission contracts (attached). Commissioner Eby seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the agreement with ZIX for email encryption services at a cost of \$5,025. Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the MH/IDD contracts for Early Intervention, Intellectual and Developmental Disabilities, and Mental Health (attached). Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the appointment of Allyson Valentine to the position of Aging Care Manager 2 at the Area Agency on Aging effective September 13, 2022 at an hourly rate of \$22.48. Commissioner Watson seconded the motion. All agreed. Motion carried.
