Commissioner Allen opened the meeting at 7:00 p.m. on September 19, 2022 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference at the Spring Township Building. The meeting was recorded by the County.

Announcements/Updates: None

Public Comments: Bill Selle questioned what the status of recycling was in the County. He said he was concerned because there is no recycling available to residents. He commented that he was aware that Wheatfield Township has recycling bins, and wondered if the cost of that type of service had been looked into. Mr. Selle also asked for a broadband update.

Jonette Zeigler said she also shares the same concerns regarding recycling. She asked if Kristie Smith, from the Conservation District, would be available to speak with about recycling.

Tereasa Houtz stated that broadband is a huge issue in the County. She provided information on the poor and unreliable service she is currently receiving through CenturyLink. She commented that it would be nice to have other options for service such as Xfinity or ZITO.

Deke Gilbert commented that he was concerned with large broadband companies buying up the smaller companies. He said the broadband companies are not held accountable for their service. Mr. Gilbert stated that ZITO had bought up smaller companies, and once ZITO took over the operations the broadband service went downhill. He commented that he thinks a comprehensive plan to install a broadband network in the County would be beneficial, but it seems like a patchwork approach is being taken instead. He said laying trunk lines of fiber seems to be a good way to get started.

Mary Colledge stated that she recently took recyclables to Halifax and they take magazines and newspapers.

Robert Wooley said that he thinks CenturyLink has sold off residential accounts of many states including Pennsylvania. He commented that this means a new company would be coming in and there is no telling what the new company's service will be. Mr. Wooley also recommended that special pages be added to the County website to provide updates on topics like broadband and recycling.

Commissioner Eby introduced the County staff in attendance at the meeting.

Approval of Minutes: Commissioner Eby made a motion to approve the minutes from the September 12, 2022 Commissioners' Meeting. Commissioner Allen seconded the motion. All agreed. Motion carried.

Meeting Business: Commissioner Eby made a motion to approve the FY 2020 CDBG-CV subrecipient agreements with Marysville Borough and Newport Borough. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the preventative maintenance program service agreement with CILS Inc. for the Prison washers and dryers. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve Resolution 2022-12 Act 57. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the agreement for architectural services with Reed E. Hoffman, Architect LLC at a cost of \$4,200. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Eby made a motion to approve the MH/IDD contracts for Intellectual and Developmental Disabilities and Mental Health (attached). Commissioner Allen seconded the motion. All agreed. Motion carried.

Public Comments: Doug Wentzel provided an update on the Spring Township Park and said the project is nearing completion. He thanked the Spring Township supervisors for their financial support.

Jason Finnerty said the County is updating its comprehensive plan, PICTURE PERRY. He said the plan would serve not only as the County's comprehensive plan, but municipalities are encouraged to sign on as well. He commented that that goal is to have one unified comprehensive plan for the County. Mr. Finnerty stated that there is no cost for municipalities to partner in the project and commented that approximately 15 out of 30 municipalities have signed onto the plan so far. He said the plan would be fluid and told attendees that questions could be directed to him.

Dr. Pat Gutheil commented that Jason Finnerty had attended her township's planning commission meeting and he provided valuable information. She said Mr. Finnerty answers any questions they have had and listens to the ideas of others as well. She encouraged municipalities to participate in PICTURE PERRY and thanked the Commissioners for standing behind the project.
