## COMMISSIONERS GENERAL SESSION October 24, 2022

Commissioner Eby opened the meeting at 10:00 a.m. on October 24, 2022 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Conference Room. The meeting was recorded by the County.

**Announcements/Updates:** Commissioner Watson commented on the downtown revitalization clean up days organized by the Perry County Economic Development Authority. She said she attended three of the events and they have been successful thanks to the numerous volunteers and the cooperation of the communities.

Commissioner Allen thanked Paul Wyatt with the Perry County Times for his article on the new location of the Voter Registration Office.

Commissioner Eby stated that the County, in cooperation with the Conservation District, is working on a letter of intent regarding a recycling grant centered around glass crushing. He also commented on a group of citizens with concerns about the homeless in the County. Commissioner Eby said the group is interested in establishing a temporary homeless shelter and they are in the beginning steps of this process. He said the County Commissioners support their efforts to move this project forward.

**Public Comments:** Sarah Keller reminded attendees of Senator DiSanto's Veterans Appreciation Breakfast. She said the event would be held on November 4, 2022 from 8:30 a.m. - 10:30 a.m. at the Scottish Rite Theatre in Harrisburg and veterans may bring one guest. She said anyone interested in more information should call her office or stop in.

Commissioner Eby stated that the Perry County Veterans Day Parade would be held on November 5, 2022 at 11:00 a.m. in Marysville. He encouraged attendance at the event.

**Approval of Minutes:** Commissioner Watson made a motion approve the minutes from the October 17, 2022 meeting. Commissioner Allen seconded the motion. All agreed. Motion carried.

**Meeting Business:** Commissioner Watson made a motion to award the bid of the 2018 John Deere 1590 no till drill to Philip L. Knicely for the price of \$28,800. Commissioner Allen seconded the motion. All agreed. Motion carried. Ben Smith, from the Soil Conservation District, recommended that the bid be accepted.

Commissioner Allen made a motion to approve the Season of Justice grant terms, conditions, and understandings agreement. Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Watson made a motion to table the proposal from Mike Cleck paving until further discussion on the project could occur. Commissioner Allen seconded the motion. All agreed. Motion carried.
