## COMMISSIONERS GENERAL SESSION November 8, 2021

Commissioner Allen opened the meeting at 10:00 a.m. on November 8, 2021 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Meeting Room. The meeting was recorded by the County.

**Announcements/Updates:** Commissioner Watson commented on the Veteran's Day Parade that occurred over the weekend. She stated that the event was well attended and was a great event.

**Public Comments:** None

**Approval of Minutes:** Commissioner Watson made a motion to approve the minutes from the November 1, 2021 Commissioners' Meeting. Commissioner Eby seconded the motion. All agreed. Motion carried.

**Approval of the Warrant List(s):** Commissioner Eby made a motion to approve the warrant lists (dated 10/25/21, 11/3/21, and 11/9/21) in the total amount of \$392,057.09 and noted that the total included ERAP payments. Commissioner Watson seconded the motion. All agreed. Motion carried.

**Meeting Business:** Marty Smith stated that recently the boiler in the Annex building needed to be replaced due to a crack. His staff was able to use an old boiler from the Courthouse to replace the broken boiler. Mr. Smith commented that his team not only moved the very large boiler from one building to another, but successfully installed the equipment in less than 24 hours. He said that the boiler inspector came in after the installation and was impressed by the work the Maintenance team had done and commented on the cost savings of using the old boiler. Mr. Smith stated that his staff consisting of Bill Wagner, Rich McEnery, and Cory Matter should be commended for their efficient work replacing the boiler, but also for the cost savings to the County.
