COMMISSIONERS GENERAL SESSION October 23, 2023

Commissioner Watson opened the meeting at 10:04 a.m. on October 23, 2023 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Conference Room. The meeting was recorded by the County and Randy Kessler.

Announcements/Updates: Commissioner Reisinger stated that Commissioner Allen was not in attendance due to medical reasons and wished him well. He also commented that the Ickesburg, Landisburg, and Loysville Lions Clubs Halloween parade happened over the weekend and Hershey donated two pallets of candy to the event. He said all the children went away with candy and he had some for all the meeting attendees.

Public Comments: Faith Pundock asked for a broadband internet update. She further questioned how boroughs and townships are informed of the broadband process.

Robbyn Metz asked for a status update on an FAQ document on the County website. She questioned if the Commissioners have thought about utilizing the Perry County Commissioners Facebook page more to alert the public of meetings. Ms. Metz asked if the budget meetings would be available for virtual participation and asked if the minutes from last year's budget meetings are available to the public.

Approval of Minutes: Commissioner Reisinger made a motion to ratify the actions taken at the October 16, 2023 meeting and approve the minutes from the October 16, 2023 meeting. Commissioner Watson seconded the motion. All agreed. Motion carried.

Approval of the Warrant List(s): Commissioner Reisinger made a motion to approve the warrant lists totaling \$390,742.85. Commissioner Watson seconded the motion. All agreed. Motion carried.

Meeting Business: Commissioner Reisinger made a motion to approve the MH/IDD contracts for Mental Health for fiscal year 2022/2023 in the total amount of \$3,133,997 (attached). Commissioner Watson seconded the motion. All agreed. Motion carried.

Commissioner Reisinger made a motion to approve the MH/IDD contracts for Mental Health, Early Intervention, and Intellectual & Developmental Disabilities for fiscal year 2023/2024 in the total amount of \$1,522,143 (attached). Commissioner Watson seconded the motion. All agreed. Motion carried.

Solicitor's Report: None

Public Comments: Patrick Port stated that he recently built a house on Hickory Ridge Road and had recently received an interim tax bill of approximately \$10,000 on top of his other tax bill for a total of almost \$20,000. He said he had filed an appeal and received notice that his appeal meeting would take place on October 30th but he is unable to attend the meeting. Mr. Port commented that his understanding was that interim tax bills will be eliminated in 2024 and asked that the interim tax be reevaluated and eventually pushed aside. He stated that this is a burden to families and tax payers.

Solicitor Bunt stated that interim tax bills have not been eliminated.

Randy Waggoner, Chief Assessor, said that Mr. Port did file his appeal timely and he had asked him to attend the Commissioners' meeting to be heard due to his scheduling conflict next week for his appeal hearing.

Solicitor Bunt recommended telephone participation for Mr. Port at his appeal meeting.
