Commissioner Watson opened the meeting at 10:00 a.m. on November 6, 2023 with the Pledge to the Flag and a moment of silence. The meeting was conducted in person and via WebEx telephone/video conference in the Commissioners' Conference Room. The meeting was recorded by the County, Paul Wyatt, and LeAnn Behrendt.

Announcements/Updates: Commissioner Reisinger commented that he had attended the Veterans Day Parade in New Bloomfield over the weekend. He said the parade was large and had a lot of participants.

Approval of Minutes: Commissioner Allen made a motion to approve the minutes from the October 30, 2023 meeting. Commissioner Reisinger seconded the motion. All agreed. Motion carried.

Approval of the Warrant List(s): Commissioner Reisinger made a motion to approve the warrant lists totaling \$355,091.05, and noted that \$61,760.93 was ERAP funds. Commissioner Allen seconded the motion. All agreed. Motion carried.

Meeting Business: Rich Fultz, EMA/911 Director, stated that the ESINet Monitoring maintenance agreement is for the statewide public safety system that carries all the radio and 911 traffic. He noted that the contract is for one year with extensions out for 5 years and commented that the cost was for the entire 5-year period. He further said that the cost is grant reimbursable via the 911 surcharge funding. Commissioner Reisinger made a motion to approve the maintenance agreement with ComPros Inc. for ESINet Monitoring at a total cost of \$361,210. Commissioner Allen seconded the motion. All agreed. Motion carried.

Commissioner Reisinger made a motion to approve the MH/IDD contracts for Intellectual and Developmental Disabilities for fiscal year 2023/2024 in the total amount of \$5,000 (attached)). Commissioner Allen seconded the motion. All agreed. Motion carried.

Rich Fultz, stated that the State Homeland Security Grant program agreement is what funds the Southcentral Task Force. He said that 9 counties participate in the task force and Perry County can be the beneficiary of the funds for training. Commissioner Reisinger made a motion to approve the FY 2023 State Homeland Security Grant program agreement. Commissioner Allen seconded the motion. All agreed. Motion carried.
