**RULES, REGULATIONS & CONDITONS GOVERNING ADULT PROBATION, PAROLE OR ARD SUPERVISION**

Upon "Order" of the Perry County Court, dated \_\_\_\_\_,  
I, \_\_\_\_\_ have been placed on probation, parole, or ARD supervision for  
a period of \_\_\_\_\_ expiration date \_\_\_\_\_, under the "control and  
jurisdiction" of Perry County Probation and Parole Department.

1. I will report to my Probation/Parole Officer when directed and will permit him/her to visit me at any place or time.
2. I will obtain approval from my Probation/Parole Officer before changing my place of residence and/or before leaving the Commonwealth of Pennsylvania for longer than 72 hours.
3. I will make every effort to maintain regular employment. If I lose or change my employment, I must report this fact to my Probation/Parole Officer. If I am unemployed, I am required to make a diligent effort to obtain employment and to provide proof of my efforts to my Probation/Parole Officer.
4. I will not consume alcoholic beverages, nor will I indulge in the use, sale, or distribution of narcotics or drugs in any form. If directed by my Probation/Parole Officer, I must submit to any recognized drug, alcohol or substance abuse testing. Furthermore, I will agree to pay for any and all testing expenses should the test prove positive for drug use. Any attempt to adulterate or substitute a urine specimen will constitute a violation of this section and I may subject myself to arrest on new charges under Title 18, Section 4910 of the PA Consolidated Statutes.
5. I will not knowingly associate with any person having a criminal record, nor visit or correspond with inmates of any prison, jail or correctional institution without first obtaining permission from my Probation/Parole Officer.
6. I will comply with all laws of the United States of America, the Commonwealth of Pennsylvania, and the community in which I live. Any violation of the law constitutes a violation of my probation/parole. I will report any new arrest(s) or questioning regarding offenses by law enforcement authorities to my Probation/Parole Officer during the next working day.
7. I will pay any and all court costs, fines, fees and/or restitution imposed by the Court in accordance with a payment plan.
8. Probation/Parole Officers have the legal authority to conduct Warrantless Searches of real property, vehicle, or personal property which is in your possession or under your control.
9. I realize that violation of any of these conditions may result in the loss of my parole or ARD probation privileges and the Court may consider commitment to a penal or correctional institution to serve out the sentence or revocation of ARD.
10. Special conditions of sentence
  - a.) Attend DUI Safe Driving Classes, take CRN Alcohol Evaluation, and pay fee of \$200 to Perry County AHSP.
  - b.) Operator License suspended by PA Department Transportation.
  - c.) Attend Alcohol Counseling and/or treatment if CRN recommends and pay expenses of same.

Whenever problems arise or you do not understand what is expected of you, contact your Probation/Parole Officer as it is his/her responsibility to help you in the interpretation of the conditions of your parole or probation.

**AGREEMENT BY PAROLEE OR PROBATIONER**

If I should be arrested in another state or country during the period of my parole or probation, I will waive extradition and will not resist being returned to the Commonwealth of Pennsylvania or the United States.

I have read, or have had read to me, the above conditions of my parole or probation. I fully understand them and agree to abide by them; and I fully understand the penalties involved should I, in any manner, violate them.
