ADDITIONAL INFORMATION

Upon filing any order, motion, petition, rule for disposition by the Court the **filing attorney/party SHALL provide the Prothonotary with copies of the document and addressed, stamped envelopes for ALL Parties.**

All filings should be one-sided with one staple in top left hand corner of the document and no backer.

There will be a charge of \$17.20 for checks returned due to insufficient funds.

Judgments must be accompanied by 236 Notices and Addressed Stamped Envelopes for All Defendants.

The Prothonotary **shall not** be required to enter on the docket any suit, action or order of court or enter any Judgment thereon or perform any service whatsoever for any person, political subdivision or the Commonwealth until the requisite fee is paid per 42 P.S. Section 21073(b).

The fee for service not herein specifically provided for or included in any other service shall be the same as for similar services.
